- 1.1 The subject of the contract shall be the supply, delivery, installation, of the following supplies:

General description of the supplies, including quantities:

- a. VR Headsets, with built-in screen (5 pieces) minimum properties:

Writing Surface: Includes an attached writing pad, usually a hinged or fixed surface on one side, made of durable plastic or laminate.

NOTE: delivery of all equipment and assembly services of the furniture and VR headsets, are required.

The place of acceptance of the supplies shall be Dom Zdravlja "Dr. Đorđe Lazić", Mirna 3, 25000 Sombor, Srbija, the time limits for delivery shall be 50 days from contract signature and the Incoterm applicable shall be DDP. The implementation period of tasks shall run from 31.03.2025. to 20.05.2025.

- 1.2 The Contractor shall comply strictly with the terms of the Special Conditions and the technical annex.

Article 2 Origin

The rules of origin of the goods are defined in Article 10 of the Special Conditions.

Article 3 Price

- 3.1 The price of the supplies shall be that shown on the financial offer (specimen in Annex IV). The total maximum contract price shall be 2.986.680,00 RSD.
- 3.2 Payments shall be made in accordance with the General and Special Conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents




The contract is made up of the following documents, in order of precedence:

- Other relevant documents

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above.
